Payment of consumer credits related to isolated purchase of airline tickets, whenever failure to provide the trip is not ascribable to the travel agency.

Who is entitle to mobilise?

obtaining payment of credits arising from failure to comply with contracts entered into with travel and tourism agencies (both incoming and outgoing).

A consumer is anyone to whom goods have been supplied, services have been provided or rights have been granted, intended to non-professional use, by anyone practicing any economic activity as a professional in order to benefit from it"

The Guaranies Fund does not pay directly to the suppliers

but only directly to the consumer and always on the basis of

a decision issued by the entities referred to in the previous

FCVIVIONISauon Procedume Decision / Judgement

Turismo de Portugal I.P notifies the travel agency for them to pay the amount within 20 business days Failure to voluntarily pay the amount, payment will be made by FGVT

The Agency must reimburse to the FGVT the amount used to pay to the consumer (within 30 business days).

Should the Agency fail to reimburse the amount, their registration at RNAVT is cancelled and it can no longer be able to exercise the activity

The Fund is managed by the State, represented by <u>Turismo de Portugal</u> <u>Governmental sody</u> with the support of the <u>General Council</u> (nonremunerated) composed of:

- Representatives from Travel Agencies: APAVT
- Representatives from Consumers: DECO e DGC

Management can be allocated to a FINANCIAL CORPORATION appointed by Turismo de Portugal after consulting the General Council

Single contribution to be made by Travel Agencies when they register with the National Registry for Travel and Tourism Agencies (RNAVT)



Agencies in practice on the date when Decree-law

61/2011, dated May 6th, entered into force

Annual progressive contribution calculated based on the respective turnover

Annual because it would be paid throughout time (in 3 years) until the right amount is attained or until the date when the Fund would attain its minimum value (€ 2,000,000.00)
